

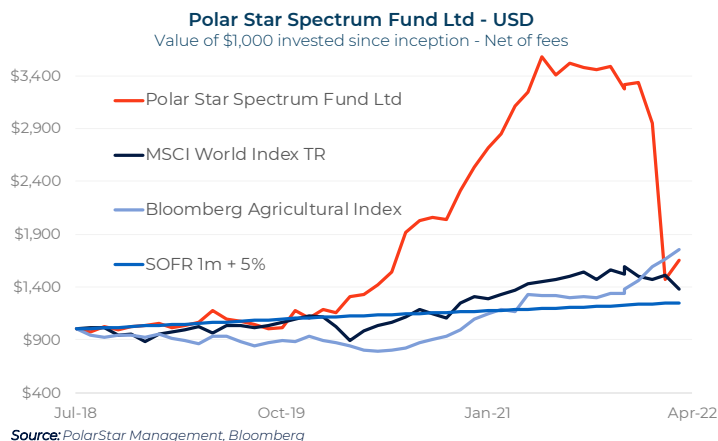
# POLAR STAR SPECTRUM FUND LTD (USD)

The portfolio is constructed through rigorous fundamental analysis and is supported by quantitative modelling.
